

Covers costs associated with responding to fraudulent electronic communications/websites designed to impersonate the insured, including;

- Press release to advise customers of the fraudulent communication
- Reimbursement to customers for their financial loss resulting directly from the fraudulent communication
- Direct loss of profits resulting from the fraudulent communication
- Costs to remove the fraudulent websites
